**THE TERMS & CONDITIONS OF THIS MoU ARE AS BELOW:**

**The 1<sup>st</sup> Party Hospital shall provide facilities to the 2<sup>nd</sup> party Institution as below:**

- The Students studying in various years of their course at the 2<sup>nd</sup> party Institution, SDM Jainmatt Trust's Jain Agm Ayurvedic Medical College Varur, Hubballi, shall visit the 1<sup>st</sup> party Hospital to observe the patients in the IPD/OPD etc., for the designated number of hours as per their Time-Table.
- As part of teaching & training needs of their respective curriculum, the said students shall observe the Medical/Surgical/ OBG procedures being conducted in the 1<sup>st</sup> party Hospital, fulfilling their curricular requirements.
- The said students shall also be exposed to the Laboratory/ USG / X-Ray & other available services/procedures, being conducted in the 1<sup>st</sup> party Hospital.
- The 1<sup>st</sup> party Hospital shall provide Laboratory/ USG/ X-Ray & other available services/ procedures to the patients of the Hospital attached to the institution of 2<sup>nd</sup> party.

**The 2<sup>nd</sup> party Institution shall ensure the following to the 1<sup>st</sup> party Hospital:**

- Availability of the designated faculty along with the students of the 2<sup>nd</sup> party institution, while visiting the 1<sup>st</sup> party Hospital.
- Own transport and other arrangements.
- The discipline and punctuality of its students.
- Replace or make good of any damage or loss made by the students of the 2<sup>nd</sup> party institution, at the 1<sup>st</sup> part Hospital.
- Ensure proper dress code for all the faculty and the students at all the times, during their presence in the 1<sup>st</sup> party Hospital.

**Both the parties herewith agree for the following:**

- There shall be no financial commitment or liability on either of parties of whatsoever nature regarding any of the clauses of this MoU, till it is in force.
- Both the parties shall not charge any fees/surcharges for any of the services rendered as per the clauses of this MoU.
- This MoU can be modified with the consent in writing, by the parties.
- This MoU can be terminated by either of the parties, with an advance notice of 30 days.
