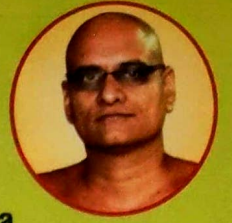

MEMORANDUM OF UNDERSTANDING

(MOU for Ambulance Services)

Between

JAIN AGM AYURVEDIC MEDICAL COLLEGE AND HOSPITAL, VARUR
(Hereinafter referred to as "THE COLLEGE")

And

SANJEEVINI SPECIALTY HOSPITAL & HEART CARE CENTRE
Shirur Park Main Road, Besides Corporation Bank,
Prashanth Colony, Vidyanagar, Hubli - 580031
(Hereinafter referred to as "THE HOSPITAL")

PREAMBLE

This Memorandum of Understanding (MOU) is entered into on this 1st day of June 2026, between the Principal, Jain AGM Ayurvedic Medical College and Hospital, Varur, and the Management of Sanjeevini Specialty Hospital & Heart Care Centre, Hubli, with the mutual intent to establish a formal arrangement for the provision of ambulance services to the College as and when required.

ARTICLE 1 - PURPOSE

The purpose of this MOU is to define the terms and conditions under which Sanjeevini Specialty Hospital & Heart Care Centre shall provide ambulance services to Jain AGM Ayurvedic Medical College and Hospital, Varur, for the transportation of patients, students, staff, or any other persons requiring emergency or non-emergency medical transport, as

determined by the College authorities.

ARTICLE 2 - DURATION

This MOU shall be effective from 1st June 2026 and shall remain in force for a period of

THREE (3) YEARS, i.e., up to and including 31st May 2029, unless terminated earlier in accordance with the provisions set forth herein.

Upon expiry, this MOU may be renewed by mutual written consent of both parties.

ARTICLE 3 - SCOPE OF SERVICES

Sanjeevini Specialty Hospital & Heart Care Centre agrees to:

- a) Make available one or more ambulances, fully equipped and staffed, to Jain AGM Ayurvedic Medical College and Hospital, Varur, as and when requisitioned by the College.
 - b) Ensure that the ambulance(s) deployed are roadworthy, equipped with basic and advanced life support equipment as applicable, and manned by trained paramedical personnel.
 - c) Respond to requisition calls from the College within a reasonable and agreed response time, particularly in emergency situations.
 - d) Maintain valid registration, permits, and insurance for all ambulance vehicles deployed under this MOU.

ARTICLE 4 - RESPONSIBILITIES OF THE COLLEGE

Jain AGM Ayurvedic Medical College and Hospital, Varur agrees to:

- a) Designate a nodal officer who shall coordinate all ambulance requisitions with the Hospital.



b) Provide advance notice for non-emergency transport requirements, wherever possible.

c) Ensure timely settlement of any charges mutually agreed upon for the services rendered under this MOU.

d) Acknowledge the services provided by Sanjeevini Specialty Hospital & Heart Care Centre in relevant institutional records and compliance documents.

ARTICLE 5 - FINANCIAL TERMS

The financial terms for ambulance services, if any, shall be mutually agreed upon between both parties separately and shall not form a binding part of this MOU. Both parties agree to discuss and finalise applicable charges, if any, at the time of each requisition or through a supplementary written agreement, as deemed appropriate.

ARTICLE 6 - CONFIDENTIALITY

Both parties agree to maintain the confidentiality of any patient-related information shared during the course of providing services under this MOU, in accordance with applicable laws and ethical standards governing medical information.

ARTICLE 7 - TERMINATION

Either party may terminate this MOU by providing a written notice of not less than 30 (thirty) days to the other party. Termination shall not affect any obligations that have arisen prior to the date of termination.

ARTICLE 8 - DISPUTE RESOLUTION



Any disputes arising out of or in connection with this MOU shall first be resolved through mutual discussion and good faith negotiation between the parties. If unresolved, the matter shall be referred to an appropriate authority acceptable to both parties.

ARTICLE 9 - GENERAL PROVISIONS

a) This MOU does not create any legal partnership, joint venture, or employment relationship between the two parties.

b) This MOU may be amended at any time by mutual written consent of both parties.

c) This MOU is non-exclusive; both parties retain the right to enter into similar arrangements with other institutions.
