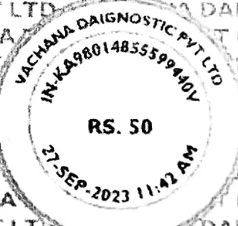

2.SERVICES PROVIDED BY VACHANA DIAGNOSTICS:

Terms and conditions:

Hospital:

- Hospital need to Inform at least 30 min prior for ambulance service requirements
- Hospital Needs to confirm on payment part, weather patient/patient attendants or hospital is going to pay the ambulance service charges
- Hospital makes possible try to gather all the patients together to send scan centre at a time, in this situation, Hospital needs to confirm on payment responsibility part

Ambulance Services:

- On request from the patient/patient attendants Scan centre must make available of Ambulance service at the earliest as possible
- Amount should be paid by the patients or patient attendants per agreed rate/Km
- Ambulance responsibility to collect the patients from the present location to Scan centre and drop back (If patients agreed for the same) to the patient's place.
- The rent for ambulance service is agreed as below
 - For Local Pick-up and Drops – Rs. 25/KM
 - For Outstation Pick-up and Drops – Rs. 35/KM
 - On patient/patient attendants request If the driver required to stay or conduct night journey then Driver Batta, and his food and accommodation Expenses needs to be paid by patient/patient attendants

This agreement will be commencing 27/09/2023 to 26/09/2028 by mutual agreement However, either party will be at liberty to terminate this agreement by giving 30 days' notice in writing after setting all its dues to the party.


